- Each performance-based restricted stock unit represents a contingent right to receive one share of common stock. The PRSUs vest upon achievement by SiTime of certain levels of relative total stockholder return over a performance period of three years ending December 31, 2026.
- Includes an aggregate of 292,447 shares of common stock issuable pursuant to previously reported restricted stock units and performance-based restricted stock units that have not vested.
